2	Accreditation of training programs	Program accreditation ensures that the quality of programs and their conformity with specified international standards is ensured through examination, review, evaluation, design and organization techniques, and suitability to suit the awarded certificate. Its accreditation criteria vary according to the type of program, the quality of its inputs and outputs, and its teaching methods.	
3	Accreditation of independent trainers	Professional accreditation for trainers deals with the quality and qualifications of the people responsible for managing training centers and those responsible for providing training, and aims to exercise commitment in implementing legal regulations, rules and protocols to maintain ethical and professional work, competence, knowledge and method in providing information and safety of interaction with recipients, to ensure the creation and development of the best experiences.
